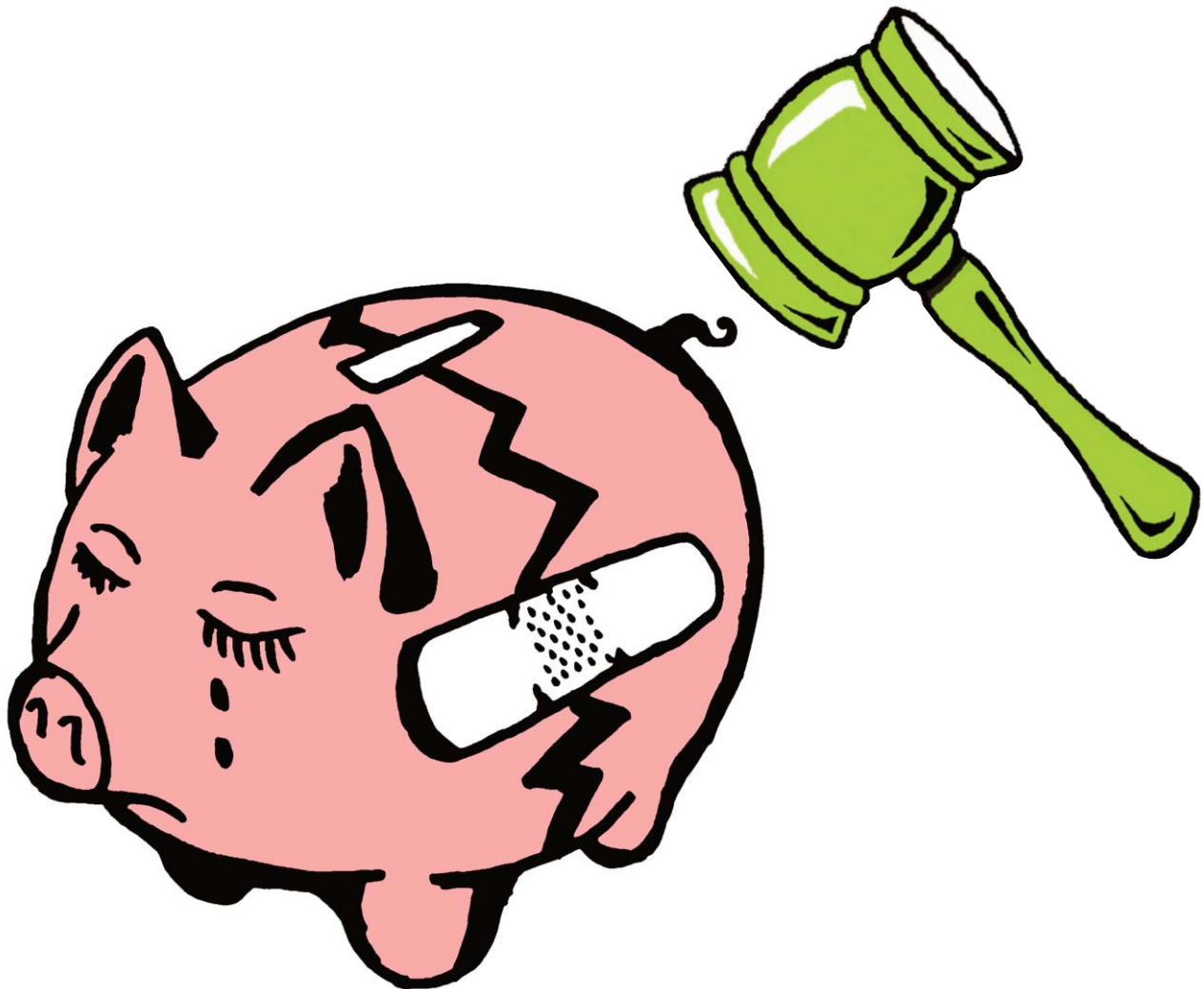

The 20th Annual Middle District Bankruptcy Bar Association Conference

will be held on June 14 and 15, 2018 at the Mohegan Sun Casino in Wilkes-Barre, PA. As in past years, the conference will offer continuing legal education credits for bankruptcy practitioners. In 2017, approximately 140 Judges, attorneys, paralegals, legal assistants and vendors attended the event.

The Middle District Bankruptcy Bar Association welcomes the Honorable U. S. Bankruptcy Chief Judge Robert N. Opel, the Honorable U. S. Bankruptcy Judge John J. Thomas and the Honorable Judge Henry Van Eck from the Middle District of Pennsylvania. We are excited to welcome our Keynote Speaker, Attorney Robert H. Davis, Jr., Adjunct Professor at Widener University. Attorney Davis will be speaking on various ethical topics, for example; what experts call the "bad file review" that allows lawyers and firms to stay well out of the way of ethics complaints and malpractice claims.

Other educational programs include Bifurcated Fees & Factoring; New Model Plan and Provisions for Both Attorneys and Paralegals; Assumption of Vehicle Loans/Leases and Reaffirmation/Cramdowns/ Redemption of Vehicle Purchase Contracts; Individual Chapter 11s - The process, differences/similarities between individual and business cases; Views from the Bench and numerous other concurrent sessions addressing evolving areas of bankruptcy law. The Schedule of Classes has various tracks for Attorneys and Paralegals/Legal Assistants. The day will offer up to 6.0 credit hours of CLE.
